Locate the application consent

- 1. Search for the application by the **ID** number if known or the **location** address.
- 2. Remove the **Assigned to me only flag** to view all applications.
- 3. Click on the **application** (not the ID) to view the status details.
- 4. Click on the consent with the status of 'Assessment in progress'.
